

June 26, 2015 SCOTUS Ruling on Same Sex Marriage

Holding: The Fourteenth Amendment requires a State to license a marriage between two people of the same sex and to recognize a marriage between two people of the same sex when their marriage was lawfully licensed and performed out-of-State.

Sweeping Federal LGBT Rights Bill from Senate, House Democrats Has Huge Support in New Poll

The Equality Act would include protections in public accommodations, public education, employment, housing, federal funding, jury service, legal protections, and credit.






With a new poll showing more than three-quarters of all Americans support the rights of lesbians, gays, bisevuals and transgender people, Democrats in both houses of Congress today introduced the most significant new legislation to protect LGBT people from discrimination.

The Equality Act would amend the Civil Rights Act of 1964 and other federal laws. But without support from the opposition, Republicans in control of both House and Senate are unlikely to



Historic Definition Of Marriage



"Every definition that I looked up, prior to about a dozen years ago, defined marriage as unity between a man and a woman as husband and wife."

Historic Definition Of Marriage



"Well, how do you account for the fact that, as far as I'm aware, until the end of the 20th century, there never was a nation or a culture that recognized marriage between two people of the same sex?

"Now, can we infer from that that those nations and those cultures all thought that there was some rational, practical purpose for defining marriage in that way or is it your argument that they were all operating independently based solely on irrational stereotypes and prejudice?"

Historic Definition Of Marriage



MS. BONAUTO: Your Honor, my position is that times can blind. And if you think about the example of sex discrimination and what it again, I assume it was protected by the Fourteenth Amendment, but it took over 100 years for this Court to recognize that a sex classification contravened (was in conflict with) the Constitution.... then came...

Craig v. Boren - 1976 Bowers v. Hardwick - 1986 Romer v. Evans - 1996 Lawrence v. Texas, - 2003 United States v. Windsor - 2013

Craig v. Boren - 1976 (ETOH) Facts of the case: Oklahoma passed a statute prohibiting the sale of "nonintoxicating" 3.2% beer to males under the age of 21 but allowed females over the age of 18 to purchase it. The statute was challenged as Fourteenth Amendment Equal Protection violation by Curtis Craig, a male who was over 18 but under 21, and by an Oklahoma vendor of alcohol. Craig v. Boren - 1976 Result of the case: The Court held that the **gender** classifications made by the Oklahoma statute were unconstitutional because the statistics relied on by the state were insufficient to show a substantial relationship between the statute and the benefits intended to stem from it. Bowers v. Hardwick (1986) In this case, the SCOTUS upheld, in a 5-4 ruling, the constitutionality of a Georgia sodomy law criminalizing oral and anal sex in private between consenting adults when applied to homosexuals. The majority opinion, written by Justice Byron White, argued that the Constitution did not confer "a fundamental right to engage in homosexual sodomy."

Bowers v. Hardwick (1986)

A concurring opinion by Chief Justice Warren E.
Burger cited the "ancient roots" of prohibitions
against homosexual sex, quoting William
Blackstone's description of homosexual sex as an
"infamous crime against nature", worse than
rape, and "a crime not fit to be named."
Burger concluded: "To hold that the act of
homosexual sodomy is somehow protected as a
fundamental right would be to cast aside
millennia of moral teaching."

Romer v. Evans - 1996


It was the first Supreme Court case to address gay rights since Bowers v. Hardwick (1986)... The Court ruled in a 6–3 decision that a state constitutional amendment in Colorado preventing protected status based upon homosexuality or bisexuality did not satisfy the Equal Protection Clause.

Lawrence v. Texas - 2003

"A landmark decision by the United States Supreme Court. In the 6–3 ruling the Court struck down the sodomy law in Texas and, by extension, invalidated sodomy laws in 13 other states, making same-sex sexual activity legal in every U.S. state and territory.

The Court overturned its previous ruling on the same issue in the 1986 case *Bowers v. Hardwick*, where it upheld a challenged Georgia statute and did not find a constitutional protection of sexual privacy.

Justice Anthony Kennedy - majority The Court held that homosexuals had a protected liberty interest to engage in private, sexual activity; that homosexuals' moral and sexual choices were entitled to constitutional protection; and that moral disapproval did not provide a legitimate justification for Texas's law criminalizing sodomy. Justice Anthony Kennedy - majority Kennedy wrote: "The petitioners [Lawrence and Garner] are entitled to respect for their private lives. The State cannot demean their existence or control their destiny by making their private sexual conduct a crime." Kennedy reviewed the assumption the court made in Bowers, using the words of Chief Justice Burger's concurring opinion in that case, that "Condemnation of [homosexual practices] is firmly rooted in Judeao-Christian moral and ethical standards." United States v. Windsor (2013) A landmark civil rights case in which the United States Supreme Court held that restricting U.S. federal interpretation of "marriage" and "spouse" to apply only to heterosexual unions, by Section 3 of the Defense of Marriage Act (DOMA), is unconstitutional under the Due Process Clause of the Fifth Amendment.

Historic Definition Of Marriage



"But you wouldn't be asking for this relief if the law of marriage was what it was a millennium ago. I mean, it wasn't possible. Same sex unions would not have opted into the pattern of marriage, which was a relationship, a dominant and a subordinate relationship. Yes, it was marriage between a man and a woman, but the man decided where the couple would be domiciled; it was her obligation to follow him...

Historic Definition Of Marriage

"We have changed our idea about marriage..."



... There was a change in the institution of marriage to make it egalitarian when it wasn't egalitarian. And same sex unions wouldn't wouldn't fit into what marriage was once."

Historic Definition Of Marriage



"That ended as a result of this Court's decision in 1982 when Louisiana's Head and Master Rule was struck down. And no State was allowed to have such a — such a marriage anymore. Would that be choice that a State should be allowed to have? To cling to marriage the way it once was?"

Historic Definition Of Marriage



"That's correct. I mean, for centuries we had we had and Europe had this coverture system where a woman's legal identity was absorbed into that of her husband and men and women had different prescribed legal roles. And again, because of equality and changing social circumstances, all of those gender differences in the rights and responsibilities of the married pair have been eliminated. And that, of course, is a system in which committed, same sex couples fit quite well."

- **2** Law, historical the legal status of a married woman, considered to be under her husband's protection and authority.

ORIGIN Middle English: from Old French, from **covrir 'to cover.'** It originally denoted a coverlet or a garment, later various kinds of covering or shelter.

The History of Coverture

- -The legal system of marriage in England from 1188 to 1870
- -The married woman was "covered" under the "protection and influence" of her husband. The wife and husband were viewed as being one legal entity.
- -Important clarification William Blackstone (1723 to 1780) said:
- "The husband is bound to provide his wife with the necessaries by law, as much as himself; and, if she contracts debts for them, he is obliged to pay them."
- -Coverture is what marriage historically was in the English and early American tradition; men controlled all property and income and men were fully legally responsible for the support of their wives.

Historic Definition Of Marriage



"Coverture was not a universal aspect of marriage around the world. And there again, if you look at the basic definition, it is between a man and a woman. It does not always say between a man and a woman in which the woman is subordinate in legal respects.

So I'm not sure it's still again a fair analogy to your situation."




















Biology matters - American College of Pediatricians March 2013

"Over thirty years of research confirms that children fare best when reared by their two biological parents in a loving low conflict marriage. Children navigate developmental stages more easily, are more solid in their gender identity, perform better academically, have fewer emotional disorders, and become better functioning adults when reared within their natural family. This is, in part, because biology contributes to parent-child bonding."

Historic Definition Of Marriage



CHIEF JUSTICE ROBERTS: Counsel, I'd like to follow up in a line of questioning that Justice Scalia started.

We have a concession from your friend that clergy will not be required to perform same sex marriage, but there are going to be harder questions. Would a religious school that has married housing be required to afford such housing to same sex couples?

Historic Definition Of Marriage



JUSTICE ALITO: Well, in the Bob Jones case, the Court held that a college was not entitled to tax exempt status if it opposed interracial marriage or interracial dating.

So would the same apply to a university or a college if it opposed same sex marriage?



GENERAL VERRILLI: You know, I I don't think I can answer that question without knowing more specifics, but it's certainly going to be an issue. I I don't deny that. I don't deny that, Justice Alito. It is it is going to be an issue.

Roberts Dissent

"The majority graciously suggests that religious believers may continue to 'advocate' and 'teach their views of marriage.

The First Amendment guarantees, however, the freedom to 'exercise' religion. Ominously, that is not a word the majority uses."

Goodridge v. Dept. of Public Health, 798 N.E.2d 941 (Mass. 2003), is a landmark state appellate court case dealing with same-sex marriage in Massachusetts.

-The November 18, 2003, decision was the first by a U.S. state's highest court to find that same-sex couples had the right to marry.

- · People in Mass have been fired for voicing religious objections to SSM.
- All businesses must recognize same sex "married" couples in all their benefits.
- The Wedding Industry Must serve the homosexual community, or be held liable for discrimination.
- · Businesses being "tested" by homosexuals (through PDA).
- Legal Profession People being "failed" on the bar exam for not answering questions concerning SSM.
- Adoption agencies retrained, 40% of adoptions are to homosexual couples.

Massachusetts

- · Church harassment
- For refusing to allow a SS couple enroll a student in their school
- For holding seminars promoting traditional marriage
- Disruption of services allowed

What can be done? (#2)

A parent should be persistent in instructing, never on any account slackening effort, ever so slightly, in the training and education of children...

Has God given explicit directions for parents to follow? Let us read what he has said, for truly we have no other authority. By reading Deuteronomy 4:6-10, the last verse more particularly, it is found that the caution is given not only to remember all that has been heard and seen, but especially to **teach the ten commandments to the children**. In Deuteronomy 6:4-7 is presented the first great commandment with promise, and that the same is to be taught diligently to children. Notice carefully the marginal reading ("whet or sharpen"). The figure used is that of a very dull-edged tool, an ax for instance. The injunction is to whet and sharpen the mind of the child diligently, by constant teaching of the commandments of God. ARSH May 14, 1889, p. 305.4

Five of the Ten

- 2nd Commandment Visiting the iniquities of the fathers upon the children
- 5th Commandment Honor thy father on thy mother that thy days may be long upon the land
- 7th Commandment Thou shalt not commit adultery
- 10th Commandment Thou shalt not covet thy neighbors wife...
- 4th Commandment Thou nor thy son, nor thy daughter, nor thy manservant... (temporal / spiritual leadership)

Don't leave it to others...

The human mind is frequently and naturally very dull, and a child's mind, if left to itself, is sure to be sluggish and stupid. It is lamentable that parents, as a rule, leave to others—disinterested parties—the training and educating of their children,—to the teachers of the day and Sabbath-schools, who have supervision over them for a brief period, an hour or so, at a time....
