




Miller's Role in Salvation History


During this controversy the Adventist preachers used "the Bible and the Bible only" as "their watchword" (*Great Controversy*, p. 63).

What is the sanctuary?

The church and/or earth

What is the cleansing of the sanctuary?

Event: The cleansing of the earth and/or church When does this judgment take place?

At the end of the 2300 years "about 1843"

Result: God justified (KJV, margin)

The Calculation of the 2300 Years

Daniel 9 is key to understanding the time of Daniel 8

- "- The 70 weeks are the key to date the 2300 days
- Both periods have the same beginning
- The dating of the 70 weeks (Dan 9:24-27)
 - -70 weeks are 490 years
 - Basis of the calculation: The year-day principle
 - When did the 490 years begin?
 - Dan 9:25 mentioned that it began with the decree to build and restore Jerusalem. It was Artaxerxes' decree issued in his 7th year (spring of 457 BC)
 - When did the 490 years end?
 - Christ died 490 years after the spring of 457 BC which is in the spring of AD 33 (490 457= 33)

Evidence for the Crucifixion in AD 33

Generally accepted date based on a scientific method

- Introduced in 13th century by Roger Bacon
- Confirmed by the Scottish astronomer James Ferguson

What was the scientific method?

- Astronomical calculations were used to find the year when Christ died
 - How is the beginning of the Jewish year calculated?
 - 1st day of the new moon nearest the spring equinox
- When is the date of the Passover?
 - The 14th day of the 1st month of the Jewish year
 - What is the correct year of the crucifixion?
 - When the 14th day of the 1st Jewish month falls on Friday







 Central was the popular view that Christ was crucified in the spring of AD 33

Incorrect view of meaning of the cleansing of the sanctuary

 The widespread understanding that earth was the sanctuary

 The cleansing of the sanctuary was the cleansing of the earth by fire

New Insights Into Prophetic Time

- 1. Adoption of the correct chronology of history
- 2. Rejection of the year AD 33 for Christ's death
- 3. Acceptance of the year AD 31 for the crucifixion.
- 4. New perspectives of Christ's sanctuary ministry-
 - J. Litch on Dan 9:24—anointing of the Most Holy
 - Christ's ascension marks His fulfillment of the antitype of the anointing of the earthly sanctuary. It marks the anointing of the heavenly sanctuary, inaugurating His ministry.
 - Wm. Miller on Lev 23 and the Day of Atonement
 - As the antitypes of the Lord's spring feasts were fulfilled at His first advent, so the autumn feasts are to be fulfilled at His second advent.

How many years are there from 2 BC to 4 AD?

Timeline of History

4 BC 3BC 2BC


1 BC 1AD 3AD 4AD

From 2 BC to 4 AD there are not 6 years but 5 full years

Notice, there is no "0" year!

How many years are there between 457 BC and 1843 AD?

There are not 2300 years but 2299 full years.
Add 1 extra year to have 2300 full years. Result: 1844



Investigation into the AD 33 Date What is the basis of the calculation of AD 33?

-The Jews in Christ's time used the current Jewish calendar (Rabbinical calendar)

Is this calendar based on the Bible?

-No. It is based on astronomical observations—it calculates the new year by the new moon nearest the vernal equinox

Why does it not use biblical reckoning?

- -It was designed by the Rabbis so Jews throughout the world could celebrate the religious feasts at the same day
- -The biblical new year is determined by agricultural conditions in Palestine. This is not suitable as a means of calculating feastdays for Jews world-wide.

Calendars and Christ's Death

Was there a calendar based upon biblical principles?

If so, is this calendar based on the Bible?

- Yes, the Jewish Karaite calendar

What was the biblical basis of this calendar?

Agricultural observations

The year began with the new moon nearest the earliest harvest (barley) in Judea, for Passover could only be celebrated when there was a harvest (Lev 23:10, 11)

If the priest observed that there was no harvest possible in the 1st month, the year would begin one month later

Can it determine Passover Friday with exactness?

No. There are no agricultural records from that time

Conclusion: No calendar can determine Passover Friday 1800 years ago with absolute certainty

Evidence of the Crucifixion in AD 31

Lk 23:44: "And it was about the sixth hour, and there was darkness over all the earth until the nineth hour" Did Luke observe a supernatural darkness?

- Yes. The darkness was "all over the earth"
 What was the position of the moon?
- The Jews began the year with the new moon
- Passover was in the middle of the 1st month (Lev 23:5) which was full moon. There was no eclipse (*Desire of Ages*, pp. 753-54)
- Were there eye witnesses of this unique darkness? Dionysius, the Areopagite, and Apollophanes, the sophist
- Place: Heliopolis, Egypt

Pagan Witnesses of the Darkness

Description of the darkness by two philosophers

- They saw "the darkness commence at the eastern limb of the sun, and proceed to the western, till the whole was eclipsed; and then regrade backwards, from the western to the eastern, till his light was fully restored"

Pagan Witnesses of the Darkness

Response to the darkness

- Apollophanes: "These, O good Dionysius, are the vicissitudes of divine events!"
- Dionysius: "Either the Deity suffers, or He sympathizes with the Sufferer!"



Now Christ's crucifixion falls in the middle of the 70th week (Dan 9:27)



Significance of AD 31 for Daniel 9

New Insight into the 70 Weeks Prophecy

The center of time prophecy: The crucifixion Christ's crucifixion moved to the middle of the 70th week in the spring of AD 31

Its impact on the 70 weeks

- The end of the 490 years became the autumn of AD 34
- The start of the 490 years became the autumn of 457 BC when the decree was promulgated and executed by Ezra

Significance of AD 31 for Daniel 8 New Insight Into the 2300 Year Prophecy

The cleansing of the sanctuary at the end of the 2300 years moved to the autumn of 1844—the season of the Day of Atonement The effect of this shift

The cleansing of the sanctuary became associated with the antitype of the Day of Atonement on the 10th day of the 7th month of the Jewish year


Result: The prophetic foundation of the SDA Church came into place

The Rise of the 7th Month Movement

-The effect of Snow's message on Adventists "Of all the great religious movements since the days of the apostles, none have been more free from human imperfection ... than was that of the autumn of 1844" (*Great Controversy*, p. 401)

New Light on the Doctrine of Christ (1)

A further unsealing of Daniel during 1843-1844

- Millerite experience led to further light into the fullness of Christ that was necessary in preparation for the 2nd advent
- 1. The cross became central in time prophecy
 - It led to a fuller understanding of Daniel 9
 - Christ's crucifixion is in the spring of AD 31
 - Christ's crucifixion is in the middle of the 70th week
 - The 490 years ended in the autumn of AD 34
 - It led to a new understanding of Daniel 8
 - The 2300 years ended in the autumn of 1844
 - Result: The prophetic foundations of the SDA Church

New Light on the Doctrine of Christ (2)

2. Impact of new light on Christ's ministry—His fulfillment of the antitypes of the OT sanctuary services and feasts A clearer understanding of Daniel 9

Type: The earthly sanctuary was anointed by Moses at the beginning of its services. Christ's crucifixion is in the middle of the 70th week

Antitype: The heavenly sanctuary (qodesh qodashim Dan 9:24) was anointed by Christ at the beginning of His ministry after His ascension— It led to a new understanding of Daniel 8

A new understanding of Daniel 8

Type: Day of Atonement was a time of judgment and cleansing the sanctuary on the 10th day of the 7th month

Antitype: The antitypical Day of Atonement was related to the final judgment and cleansing at the end of the 2300 years on the 10th day of the 7th month—Oct. 22, 1844


